The Parliament and the Council of the European Union introduced new directives on 13th August 2012 relating to old electrical and electronic equipment (WEEE) and a new directives on 3rd January 2013 and 22nd July 2019.

GENEREX is pursuing the goal of achieving compliance with both directives. We manufacture 99% of our products ourselves, so we have already taken care that all our suppliers and their components meet the ROHS/WEEE standards.

The devices sold by GENEREX are not suited for the disposal via the consumer waste. A disposal like that could lead to environmental contamination. GENEREX is registered at the donation for electrical old appliances under WEEE number DE77337052 and will take back all achieved devices after the 23.03.2006 for disposal, if the customer is a European Union resident or rather the goods were sold into the EU. All devices can be sent back to GENEREX, after consulting (call +49-40-226929110, mail support@generex.de), at the expense of the customer (Incoterms 2010 "DDP") for proper disposal and recycling.
